MEXICO-CANADA TRADE January- November 2010

Trade Among NAFTA Partners

Region of North America

- By November of 2010, total trade in the NAFTA Region recorded a value of **USD\$802.7 billion**, equivalent to a **growth of 26.7%**, compared to the previous year's same period.
- Nevertheless, **regional trade in North America is still 9.2% below the trade flows registered when the crisis started** (trade was USD\$884.2 billion in November 2008).
- During this same period, the flows of the **Mexico-Canada trade increased 39.2%** compared to last year, resulting in **USD\$27.4 billion**. This trade value **has surpassed in a 13.4%** the trade levels observed before the international crisis started (in November 2008 bilateral trade was USD\$24.1 billion).
- However, the increase in the Mexico-Canada trade has presented a downturn trend that went from levels of 56% in March to 39% in November.
- Historically, during the NAFTA age, the bilateral trade exchange has grown **almost 7 times**, that is equivalent to an average annual growth rate of 12.6% between 1993 and 2010.
- As for the **bilateral trade between Mexico and the United States**, the goods exchange increased 31.1%, amounting **USD\$341.9 billion**.

Mexico – Canada Trade

- The trade surplus that Mexico kept with Canada in November was **USD\$11.7 billion**, amount **USD\$5.2 billion higher** than the number registered last year. This surplus also represents an increase of USD\$1.2 billion against November 2010.
- Mexico kept its position as Canada's **3rd largest trade partner in the world**, covering the Canadian market with 3.9%, increasing its participation 0.5% since last year. United States is in the first position with 61.1%, and China in second, with 7.1%.

1 The information contained in this report was developed using importer's numbers shown in official sources such as BANXICO, Statistics Canada and USDOC (in the section of trade by province, only data from Statistics Canada was used). Figures shown are in USD in accordance to the average nominal exchange rate observed in the mentioned period.

COMERCIO MÉXICO-CANADÁ Enero - Noviembre 2010

Comercio Entre los Países del TLCAN Región de Norte América

- En noviembre 2010, el valor del comercio total de la región TLCAN fue de **US\$802.754 mdd** (millones de dólares estadounidenses), lo que representa un **crecimiento de 26.7%** respecto al mismo mes del año anterior.
- No obstante, el comercio en la **región de Norteamérica aún se encuentra 9.2% por debajo de los niveles registrados al inicio de la crisis** (en noviembre 2008 el comercio fue de 884,275 mdd).
- En relación al **comercio bilateral México – Canadá, los flujos crecieron 39.2%** respecto al año anterior, ubicándose en **US\$27,422 mdd**. Este valor **ha permitido superar en 13.4% los niveles de comercio observados al estallar la reciente crisis económica internacional** (a noviembre de 2008 el comercio bilateral fue de US\$24,190 mdd).
- Sin embargo, el crecimiento en el comercio México Canadá ha mostrado una tendencia hacia la desaceleración, pasando de niveles de 56% en marzo de 2010 a 39% al mes de noviembre.
- Históricamente, en la era del TLCAN el intercambio comercial bilateral ha crecido **casi 7 veces**, lo que equivale a una tasa de crecimiento anual promedio de 12.6% entre 1993 y 2010.
- En relación al **comercio bilateral México-EE.UU.**, el intercambio de bienes creció 31.1%, para ubicarse en los **\$341,956 mdd**.

Balanza Comercial México - Canadá

- El superávit comercial con Canadá en noviembre fue de **US\$11,797**, monto superior en **US\$5,208 mdd** respecto al año anterior. Este superávit además representa un aumento de **USD\$1,256 mdd** respecto a octubre de 2010.
- A nivel mundial, México se ubicó como el **tercer socio comercial** de Canadá con el 3.9% del mercado canadiense, aumentando en 0.5% su participación respecto al año anterior. Esta posición es superada por EE.UU. (61.1%) y China (7.1%).

Canadian Exports to Mexico:

- **Mexico is the 5th largest export market** for Canadian products (2.2% from the total), after the United States, the United Kingdom, China and Japan, in that order.
- In terms of value, **exports from Canada to Mexico** reached **USD\$7.8 billion**, amount 655% higher than sales recorded in 1993.
- However, because of the global financial crisis, the Mexican market for Canadian products **contracted 9.8% since 2008**.
- The average annual growth rate of **exports from Canada into Mexico** between 1993 and 2010 is **12.7%**.

Mexican Exports to Canada:

- By November 2010, Mexico kept its position as the **3rd greatest supplier for the Canadian market** (5.5%), only exceeded by imports from the United States (50.5%) and China (11%).
- Exports of **Mexican products to Canada** in this period totalled **USD\$19.6 billion**, **651% more than exports registered in 1993** (USD\$2.6 billion). The average annual growth rate of **exports from Mexico into Canada** was **12.6%**.

Main Products:

- Colour television sets keep their position as product number one to export from Mexico to Canada with 7.6% from total value (USD\$1.4 billion). Following in position number two to five are vehicles with engines between 15000 and 3000 cc, loading trucks with loads of less than 5 tons, telephone kits for cellular networks, and computers. These are the main exported products not related to the petroleum sector.
- These five products also hold 29% of total exports from Mexico to Canada.
- As for product, exports goods from Mexico with a greater increase were: loading trucks with loads up to 20 tons, semi-trailer tractors, automobiles with engine higher than 1500 cc, auto-parts (ignition cables and seats), crude oil, electronic products (cell phones) and tractors.

Exportaciones de Canadá a México:

- **México es el quinto mercado de exportación** para los productos canadienses (2.2% del total), por debajo de EE.UU, Reino Unido, China y Japón.
- En términos de valor, las **exportaciones de Canadá a México** se ubicaron en **US\$7,813 mdd**, monto 655% superior al registro de 1993.
- Sin embargo, resultado de la crisis financiera internacional, el mercado mexicano para los productos canadienses **se ha contraído 9.8% desde 2008**.
- La tasa de crecimiento anual promedio de las **exportaciones de Canadá a México** entre 1993 y 2010 se ubica en **12.7%**.

Exportaciones de México a Canadá

- En noviembre de 2010, México mantuvo su posición como **tercer proveedor de Canadá** (5.5%), participación superada por las importaciones provenientes de EE.UU. (50.5%) y China (11.0%).
- Las exportaciones de productos mexicanos a Canadá en este período sumaron **US\$19,610 mdd**, **651% más el valor de las exportaciones registradas en 1993** (US\$2,610 mdd). La tasa de crecimiento anual promedio de las exportaciones mexicanas en la era TLCAN se ubica en **12.6%**.

Principales productos:

- Los televisores a color se mantienen como principal producto de exportación de México a Canadá con el 7.6% del valor total (USD\$1,496 mdd). Vehículos con motor entre 15000 y 3000 cc, camiones para carga inferior a 5 toneladas, equipos de telefonía celular y computadoras ocupan de la segunda a la quinta posición como principales exportaciones no petroleras.
- Estos cinco productos además concentran el 29% de las exportaciones totales de México a Canadá.
- **Los productos de exportación de México que registraron mayor crecimiento en el periodo fueron:** camiones para carga de hasta 20 toneladas, tractores para semirremolques, automóviles con motor superior a 1500 cc, autopartes (cables para encendido y asientos), petróleo crudo, equipos electrónicos (celulares y computadoras), y tractores.

Investment from Canada in Mexico

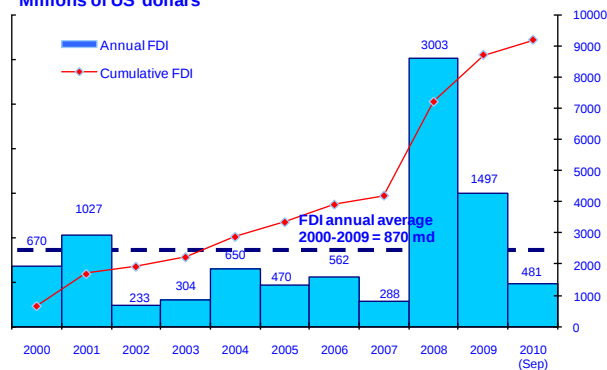
During the last sixteen years, Canadian foreign direct investment (FDI) has been a key factor for the integration of our productive sectors:

From January 2000 to September 2010, Canada's cumulative FDI in Mexico reached \$9.2 billion USD, becoming the fourth largest foreign investor in Mexico.

According to the Ministry of Economy, on September 2010, 2,563 firms were registered in Mexico as having Canadian capital.

These results demonstrate the high confidence that the NAFTA's legal framework has granted to Canadian investors to operate in Mexico.

Inversión de Canadá en México

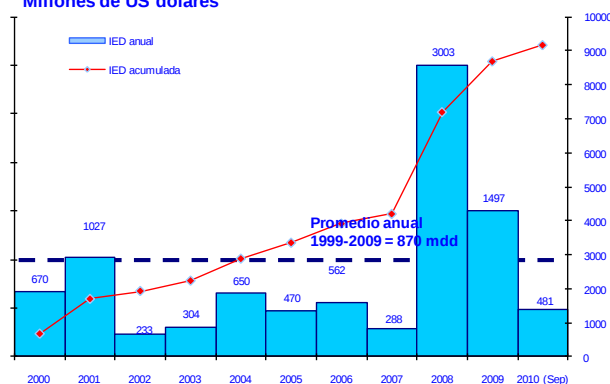
Durante los últimos dieciséis años la inversión extranjera directa (IED) de Canadá ha sido un elemento clave para la integración de los sectores productivos de ambos países:

En el período enero de 2000 – septiembre de 2010, la IED acumulada de Canadá en México alcanzó los US\$9,185 millones de dólares, lo que lo ubicó como el cuarto país inversionista en México

En septiembre de 2010, 2,563 empresas se encontraban operando en México con participación de capital canadiense.

Estos indicadores comprueban el alto grado de confianza que el marco legal del TLCAN ofrece a los inversionistas canadienses para operar en México.

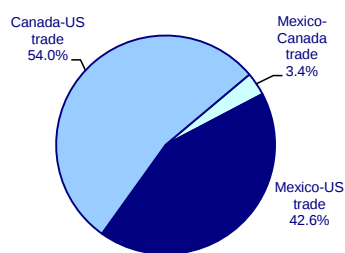

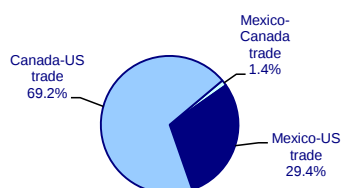

Trade Between NAFTA Partners (NAFTA trilateral trade growth January - November 10/93 = 202%)

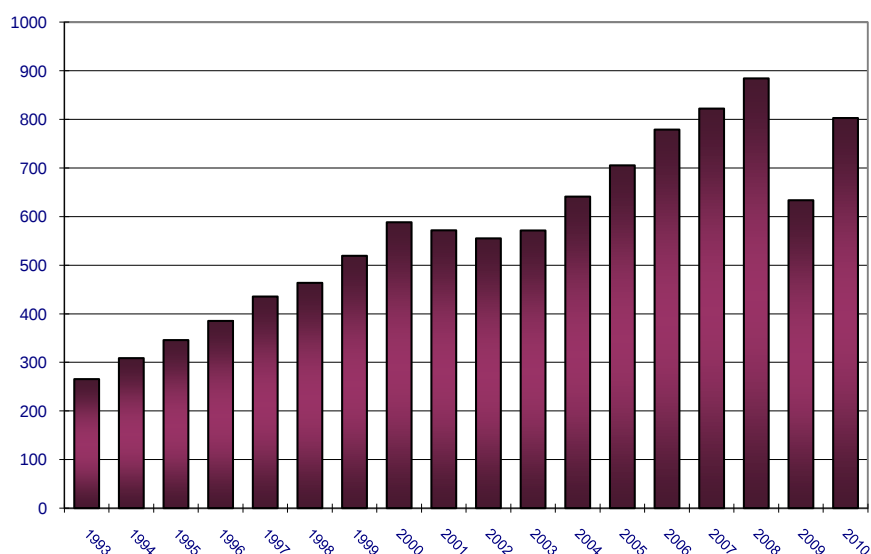
2010

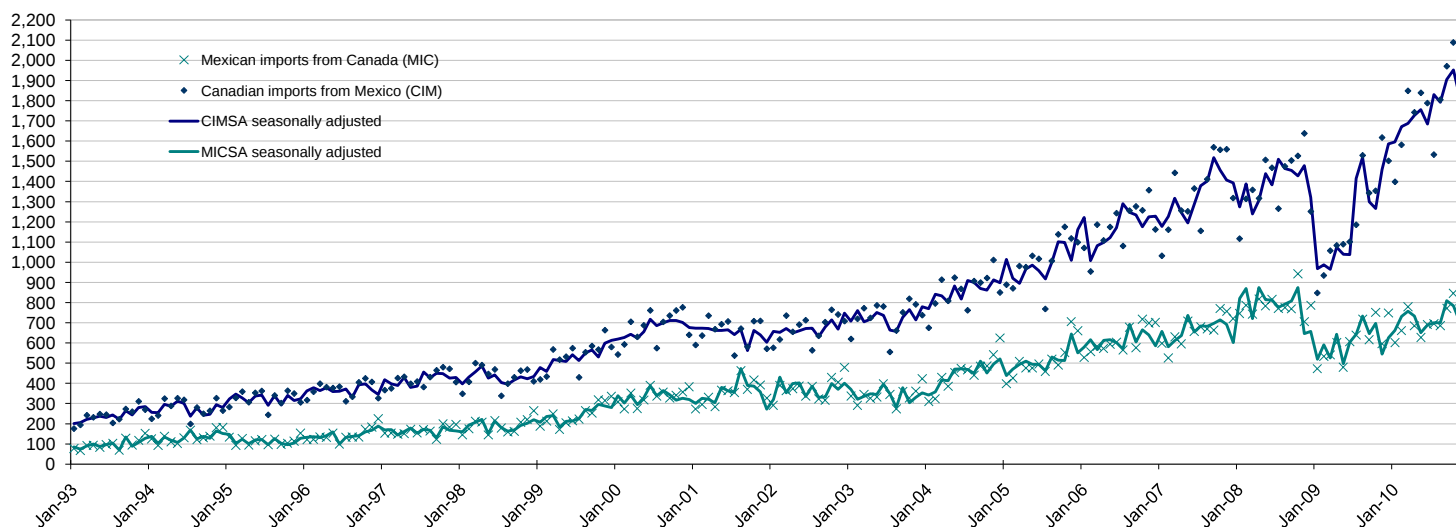

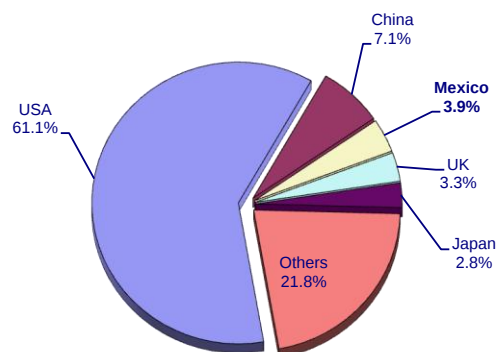

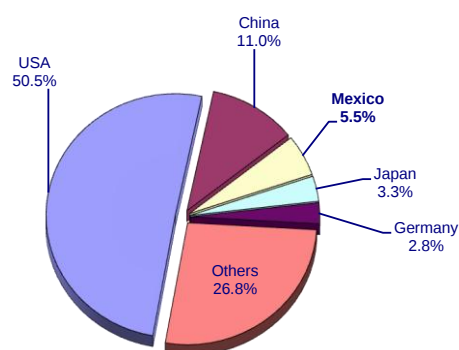

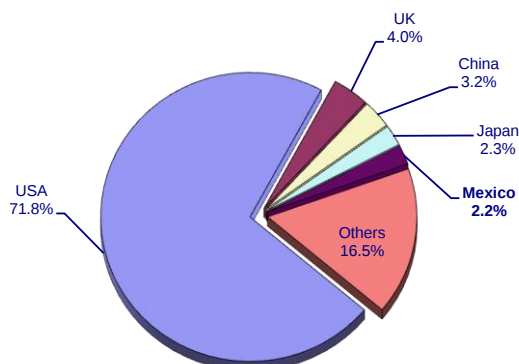
**Canada's main trading partners
