MEXICO-CANADA TRADE January – August 2011

Trade Among NAFTA Partners

Region of North America

- Between January and August of 2011, the total trade at the NAFTA region recorded a value of **USD\$669 billion**, what represents a **growth of 16.2%** in comparison to the same period last year.
- As for **bilateral trade between Mexico and Canada, flows grew 19.3%**, resulting in **USD\$22.5 billion**. This value represents a trade increase of **823.1%** during the NAFTA era, which can also be read as an average annual growth rate of 13.1% between 1993 and 2011.
- **Between 2009 and 2011, trade between Mexico and Canada grew 68.4%**, allowing a quick recovery from the recent recession.
- Regarding the **bilateral trade between Mexico and the United States**, the goods exchange increased **18.9%**, amounting **USD\$288.4 billion**.

Mexico – Canada Trade Balance:

- Mexico increased its **trade surplus** with Canada by **30%**, going from **USD\$8 billion** on August 2010 to **USD\$10.4 billion** in 2011.
- Mexico ranked as Canada's **3rd largest trade partner in the world**, covering **3.8% of the Canadian market**, with United States being in the first position with 60.1% and China in second with 7.0%.
- Among Canada's major trading partners, the growth of trade with Mexico reached the third highest level (19.3%), surpassed by China (21%) and the United Kingdom (20.1%) in the first position.

¹ The information contained in this report was developed using importer's numbers shown in official sources such as BANXICO, Statistics Canada and USDOC (in the section of trade by province, only data from Statistics Canada was used). Figures shown are in USD in accordance to the average nominal exchange rate observed in the mentioned period.

COMERCIO MÉXICO-CANADÁ Enero – Agosto 2011

Comercio Entre los Países del TLCAN

Región de Norte América

- Entre enero y agosto de 2011, el valor del comercio de la región TLCAN fue de **US\$669,370 mdd** (millones de dólares estadounidenses), lo que representa un **crecimiento de 16.2%** comparado con el mismo período del año anterior.
- En relación al **comercio México – Canadá, los flujos crecieron 19.3%**, ubicándose en **US\$22,597 mdd**. Este valor representa un crecimiento del comercio de **823.1%** en la era del TLCAN, lo que además se traduce en una tasa de crecimiento anual promedio de 13.1% entre 1993 y 2011.
- **Entre 2009 y 2011, el comercio México – Canadá ha crecido 68.4%**, permitiendo una rápida recuperación de la reciente recesión.
- En relación al **comercio México-EE.UU.**, el intercambio de bienes creció **18.9%**, para ubicarse en **\$288,426 mdd**.

Balanza Comercial México - Canadá

- México incrementó en **30% el superávit comercial** con Canadá, al pasar de **US\$8,095 mdd** en agosto de 2010 a **US\$10,487 mdd** en 2011.
- A nivel mundial, México se ubicó como el **tercer socio comercial** de Canadá con el 3.8% del mercado canadiense, por debajo de EE.UU. (60.1%) y China (7.0%).
- Entre los principales socios comerciales de Canadá, el crecimiento del comercio con México alcanzó el tercer nivel más alto (19.3%), superado por China (21%) y Reino Unido (20.1%).

En la sección de comercio por Provincia se utilizan únicamente datos de Statistics Canada. Exports from Canada to Mexico

- By August 2011, **Mexico** was ranked the **5th largest export market** for Canadian products (2% from total), only after the United States, United Kingdom, China and Japan.
- In terms of value, **exports from Canada to Mexico** reached **USD\$6 billion**, amount 787.4% higher than sales recorded in 1993.
- On a province level, Mexican exports to Nova Scotia increased 55.6%, 38.7% to Alberta, and 30.1% to Manitoba. In contrast, exports to Quebec, second provincial destination for Mexican products, fell by 6.4% in comparison to the same period last year.
- The average annual growth rate of **exports from Canada into Mexico** between 1993 and 2011 is **12.9%**.

Exports from Mexico to Canada

- By the end of the first eight months of 2011, Mexico kept its position as the **3rd largest supplier for the Canadian market** (5.5%). This participation is only exceeded by imports from the United States and China.
- August exports of Mexican products to Canada amounted **USD\$16.5 billion**, which is **more than 8.4 times the sales of August 1993** (USD\$1.7 billion). The average annual growth rate of exports from Mexico to Canada was **13.2%**.

Main products

- The Mexican export goods with a greater increase in August 2011 were: electrical panels, gold, mobile phones, devices for data reception and distribution, televisions, computers, automobile engines, and loading trucks with loads between 5 and 20 tons.

Exportaciones de Canadá a México

- A agosto de 2011, **México** se ubicó como **quinto mercado de exportación** para los productos canadienses (2% del total), por debajo de EE.UU, Reino Unido, China y Japón.
- En términos de valor, las **ventas de Canadá a México** se ubicaron en **US\$6,055 mdd**, monto 787.4% superior al monto registrado en 1993.
- A nivel provincia, las exportaciones mexicanas a Nueva Escocia crecieron 55.6%, 38.7% a Alberta y 30.1% a Manitoba. En contraste, las ventas a Quebec, segundo destino provincial para productos de México, cayó 6.4% en relación al mismo período de 2010.
- La tasa de crecimiento anual promedio de las **exportaciones de Canadá a México** entre 1993 y 2011 se ubica en **12.9%**.

Exportaciones de México a Canadá

- Durante los primeros ocho meses de 2011, México mantuvo su posición como **tercer proveedor de Canadá** (5.5%), participación superada por las compras de Canadá a EE.UU. y China.
- Las exportaciones de productos mexicanos a Canadá en agosto sumaron **US\$16,542 mdd**, monto equivalente a **8.4 veces el valor respecto a agosto de 1993** (US\$1,766 mdd). La tasa de crecimiento anual promedio de las exportaciones mexicanas en la época del TLCAN se ubicó en **13.2%**.

Principales productos

- Los bienes de exportación de México con mayor crecimiento a agosto de 2011 fueron: paneles eléctricos, oro, teléfonos celulares, aparatos para la recepción y distribución de datos, televisores, computadoras, cajas de transmisión y motores para automóviles, y camiones para carga entre 5 y 20 toneladas.

Investment from Canada in Mexico

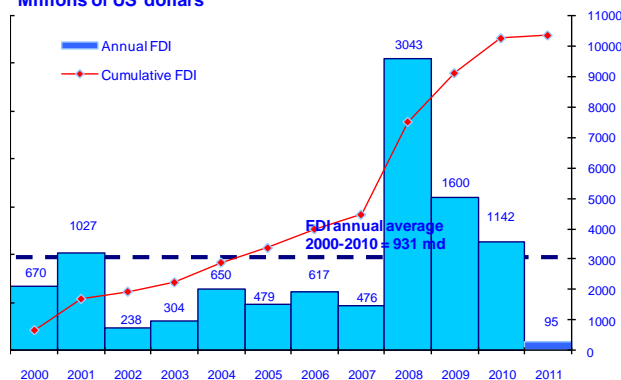
During the last seventeen years, Canadian foreign direct investment (FDI) has been a key factor for the integration of our productive sectors:

From January 2000 to June 2011, Canada's cumulative FDI in Mexico reached \$10.3 billion USD, becoming the fourth largest foreign investor in Mexico after USA, Spain and Netherlands.

According to the Ministry of Economy, on December 2010, 2,636 firms were registered in Mexico as having Canadian capital.

These results demonstrate the high confidence that the NAFTA's legal framework has granted to Canadian investors to operate in Mexico.

Inversión de Canadá en México

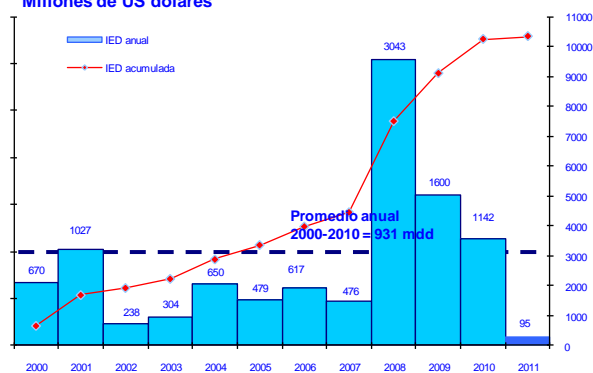
Durante los últimos diecisiete años la inversión extranjera directa (IED) de Canadá ha sido un elemento clave para la integración de los sectores productivos de ambos países:

En el período enero de 2000 – junio 2011, la IED acumulada de Canadá en México alcanzó los US\$10,340 millones de dólares, lo que lo ubicó como el cuarto país inversionista en México después de EE.UU., España y Holanda.

En diciembre de 2010, 2,636 empresas se encontraban operando en México con participación de capital canadiense.

Estos indicadores comprueban el alto grado de confianza que el marco legal del TLCAN ofrece a los inversionistas canadienses para operar en México.

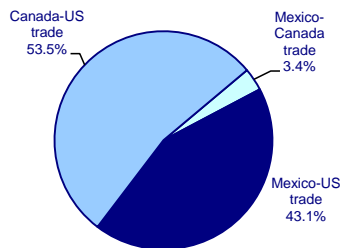

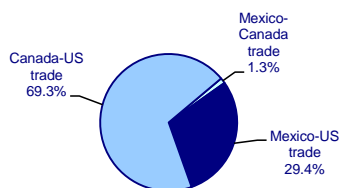

(NAFTA trilateral trade growth January - August (11/93 = 255%))

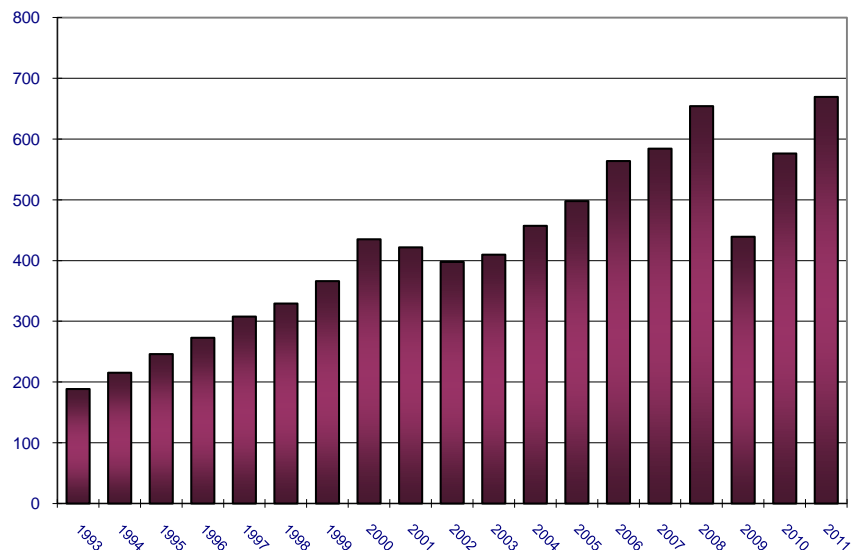

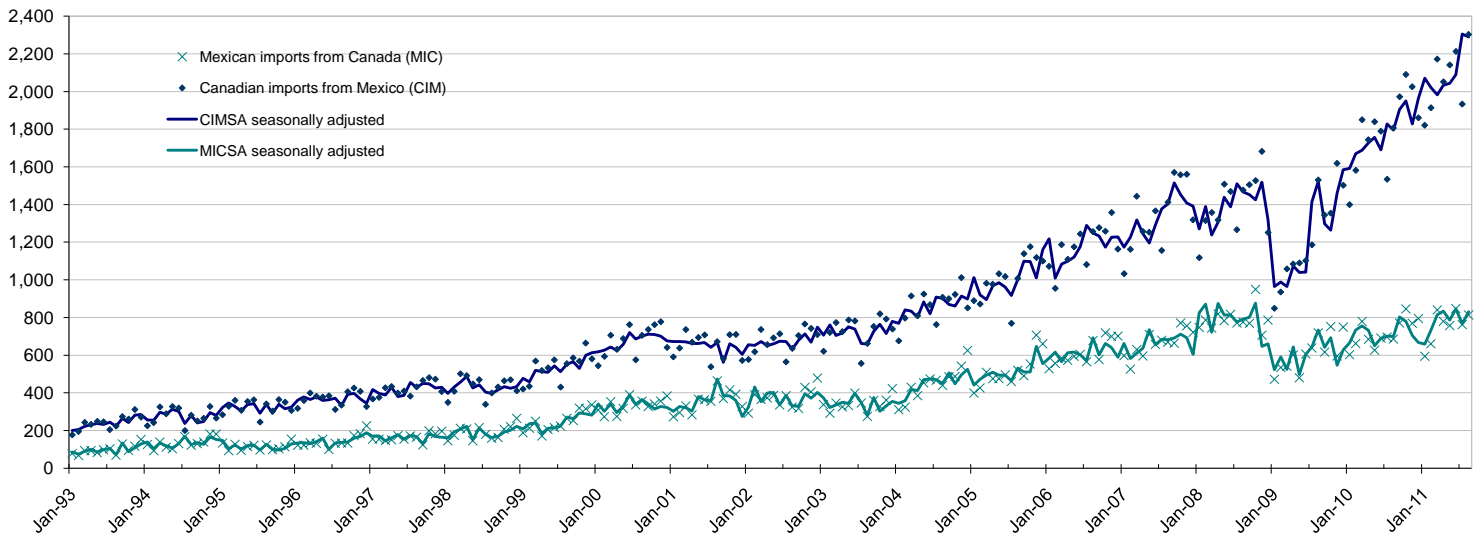

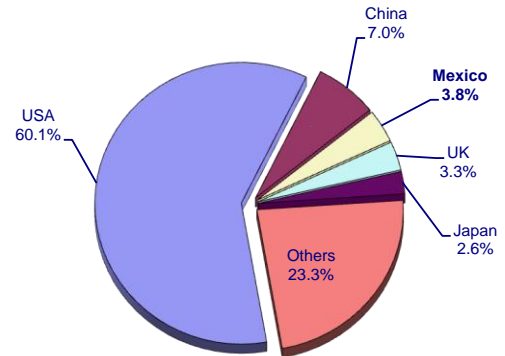

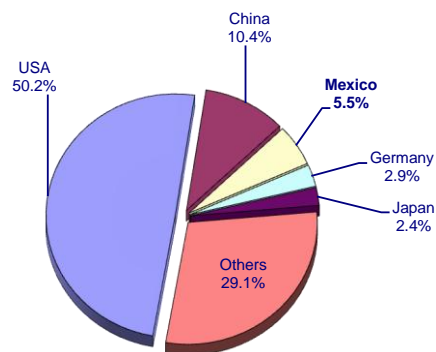

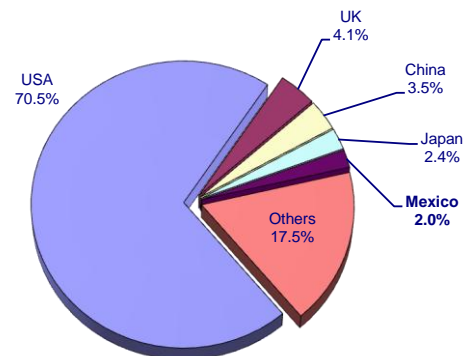
**Canada's main trading partners

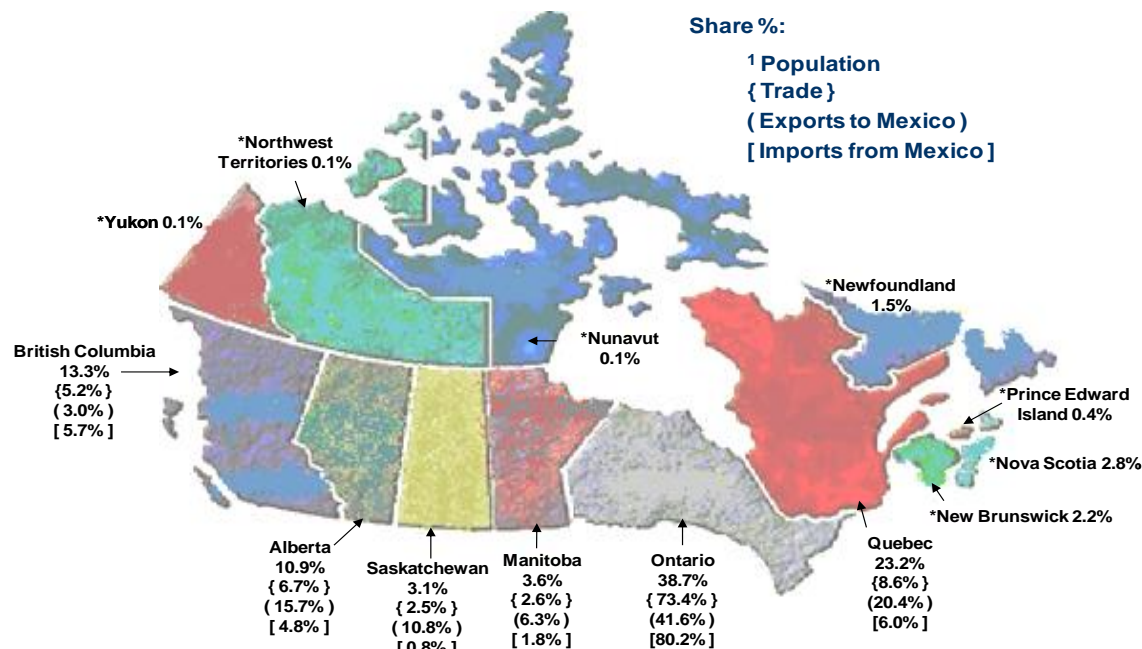
