MEXICO-CANADA TRADE
August 2012

Trade Among NAFTA Partners

Region of North America

- By the end of August 2012, total trade in the NAFTA Region recorded a value of **USD\$705.6 billion**, equivalent to a **growth of 5.6%** compared to the previous year's same period.
- Within the block of North America, Mexico's trade, along with its partner countries, went from 30.7% of the region's total back in August 1993, to 46.5% in August 2012, reflecting the importance of Mexico as a trading partner of Canada and the United States.
- As for the **Mexico-Canada trade, flows increased 2.4%, amounting USD\$23.2 billion**. This value represents a bilateral trade increase of **846%** in the NAFTA era, which also translates as an average annual growth rate of 12.6% between 1993 and 2012, **the highest within the region**.
- In regard to **Bilateral Trade between Mexico and the United States**, the goods exchange increased 7.1%, resulting in **USD\$308.5 billion**.

MEXICO – CANADA TRADE BALANCE

- **The trade surplus of Mexico decreased 1.5%**, going from **USD\$10.5 billion** in the first eight months of 2011 to **USD\$10.4 billion** in the same period of 2012.
- Mexico kept its position as Canada's **3rd greatest trade partner in the world**, covering 3.6% of the Canadian market, only after the United States (57.9%) and China (7.0%).

¹ The information contained in this report was developed using importer's numbers shown in official sources such as BANXICO, Statistics Canada and USDOC (in the section of trade by province, only data from Statistics Canada was used). Figures shown are in USD in accordance to the average nominal exchange rate observed in the mentioned period.

Comercio Entre los Países del TLCAN

Región de Norte América

- En agosto de 2012, el valor del comercio total de la región TLCAN fue de **US\$705,579 mdd** (millones de dólares estadounidenses), lo que representa un **crecimiento de 5.6%** comparado con el mismo período del año anterior.
- Dentro del bloque de Norteamérica, el comercio de México con sus países socios pasó del 30.7% del total de la región en agosto de 1993 al 46.5% en agosto de 2012, lo que refleja la importancia de México como socio comercial de Canadá y EE.UU.
- Entre **México y Canadá los flujos comerciales crecieron 2.4%**, para alcanzar los **US\$23,156 mdd**. Este valor representa un crecimiento en el comercio bilateral de **846%** en la era del TLCAN, lo que se traduce en una tasa de crecimiento anual promedio de 12.6% entre 1993 y 2012, **la más alta dentro de la región**.
- En relación al **comercio México - EE.UU.**, el intercambio de bienes creció 7.1%, para ubicarse en **US\$308,514 mdd**.

BALANZA COMERCIAL MÉXICO - CANADÁ

- **El superávit comercial de México disminuyó en 1.5%**, al pasar de **US\$10,512 mdd** en los primeros ocho meses de 2011 a **US\$10,354 mdd** en el mismo mes de 2012.
- A nivel mundial, México se mantuvo como el **tercer socio comercial de Canadá** con el **3.6% del mercado canadiense**, por debajo de EE.UU. (57.9%) y China (7.0%).

EXPORTS FROM CANADA TO MEXICO

- By August 2012 and after a contraction of 0.2% from last month's figure, Mexico still kept its position as **Canada's 5th largest export market for Canadian products** (1.9%) and was only exceeded by imports from the United States, the United Kingdom, China and Japan.
- In terms of value, **sales from Canada to Mexico** reached **USD\$6.4 billion**, 838% higher than sales carried out in 1993 and 5.7% more than same period last year.
- The average annual growth rate of **exports from Canada into Mexico** between August 1993 and August 2012 is **12.5%**.

EXPORTS FROM MEXICO TO CANADA

- On a provincial level, in comparison to last year's numbers, Augusts' exports from Mexico to New Brunswick grew 69.4%, 39% to Nova Scotia and 36.9% to Saskatchewan. These increases contrast with smaller sales to Prince Edward Island (-64.5%), and Ontario (-2.4%).
- During the eight months of 2012, Mexico kept its position as the **3rd greatest supplier for the Canadian market** (5.4%), after purchases from Canada to United States and China.
- Exports of **Mexican products to Canada** in August 2012 totalled **USD\$16.8 billion**, amount **9.5 times higher than the trade value registered in 1993** (USD\$1.7 billion). The average annual growth rate of **exports from Mexico into Canada** in the NAFTA era was **12.6%**.

Main Products:

Mexican not-oil related export goods to Canada with a greater increase in August 2012 in regards to August 2011 were: highway tractors for semitrailer for loads, auto-parts (for seats 25.6%, and wiring 19.2%), and data transfer and routing machines (28.3%).

Particularly notable is the -37.9% drop in exports of mobile phones, -16.5% drop in the case of colour TV's, and -7.1% drop of automobiles with engines between 1501 and 3000 c.c.

EXPORTACIONES DE CANADÁ A MÉXICO

- Al mes de agosto de 2012, **México** se ubicó como **quinto mercado de exportación** para los productos canadienses (1.9% del total) una contracción de 0.2% respecto al mes anterior, ubicándose por debajo de EE.UU., Reino Unido, China y Japón.
- En términos de valor, las **ventas de Canadá a México** se ubicaron en **US\$6,401 mdd**, monto 838% superior al monto registrado en 1993 y 5.7% superior al mismo período del año anterior.
- La tasa de crecimiento anual promedio de las **exportaciones de Canadá a México** entre 1993 y 2012 se ubica en **12.5%**.

EXPORTACIONES DE MÉXICO A CANADÁ

- A nivel provincial, a comparación del año anterior, en agosto las exportaciones de México crecieron 69.4% a New Brunswick. 39% a Nueva Escocia y 36.9% a Saskatchewan. Estos incrementos contrastan con las menores ventas a Prince Edward Island (-64.5%) y Ontario (-2.4%).
- En el octavo mes de 2012, México mantuvo su posición como **tercer proveedor de Canadá** (5.4%), participación superada por las compras de Canadá a EE.UU. y China.
- Las exportaciones de productos mexicanos a Canadá al mes de agosto sumaron **US\$16,755 mdd**, monto **9.5 veces superior respecto a 1993** (US\$1,766 mdd). La tasa de crecimiento anual promedio de las exportaciones mexicanas en la época del TLCAN se ubicó en **12.6%**.

Principales productos de exportación:

Los bienes de exportación no-petroleros de México con mayor crecimiento en agosto de 2012 respecto a 2011 fueron: tracto-camiones de carretera para semirremolques de carga (48.2%), autopartes (partes para asientos, 25.6% y cableado eléctrico, 19.2%), y máquinas para transmisión y enrutamiento de datos (28.3%).

Destacan en sentido inverso las caídas en las exportaciones de celulares (-37.9%, -16.5% en el caso de televisores a color y -7.1% los automóviles para pasajeros con motor de entre 1501 y 3000 c.c.

Investment from Canada in Mexico

During the last twelve years, Canadian foreign direct investment (FDI) has been a key factor for the integration of our productive sectors:

From January 2000 to June 2012, Canada's cumulative FDI in Mexico reached \$ 11.6 billion USD, becoming the fourth largest foreign investor in Mexico after USA, Spain and Netherlands.

According to the Ministry of Economy, on July 2012, 3,059 firms were registered in Mexico as having Canadian capital.

These results demonstrate the high confidence that the NAFTA's legal framework has granted to Canadian investors to operate in Mexico.


Inversión de Canadá en México

Durante los últimos doce años la inversión extranjera directa (IED) de Canadá ha sido un elemento clave para la integración de los sectores productivos de ambos países:


En el período de enero 2000 – Junio 2012, la IED acumulada de Canadá en México alcanzó los US\$ 11,610 millones de dólares, lo que lo ubicó como el cuarto país inversionista en México después de EE.UU., España y Países Bajos.

En Julio 2012, 3,059 empresas se encontraban operando en México con participación de capital canadiense.

Estos indicadores comprueban el alto grado de confianza que el marco legal del TLCAN ofrece a los inversionistas canadienses para operar en México.








Canada's main trading partners

Canada - Mexico Trade by Province, (1993 - 2012) (millions of US dollars)


